Export of Equine Semen 2016

NOTES FOR STALLION OWNERS

Conditions for international trade in frozen semen are set by each importing country. They are liable to change without notice. The information given here summarises what we understand the requirements to be at the time of writing. No two countries have identical requirements, and it is important to be aware of this when selecting the markets for which you would like semen from your stallion to be frozen for. We can obtain information on countries not listed here on request. The main points of difference are: -

1. Residence in the UK before entering the AI Centre for Quarantine

Australia:	90 days (<u>U.K. or E.C.</u>)
Canada, N.Z.:	60 days
South Africa:	11 months
E.C., U.S.A.:	Nil

2. Health Status of Stallion and Premises of Origin

The stallion must not be used after the pre-entry samples have been taken and must arrive at the centre within 20 days of the samples being taken.

Australia and N.Z. require the stallion never to have tested positive for CEM (for Australia, this includes his dam).

EVA vaccinated stallions cannot be exported to South African.

3. Earliest Date for Completion of Export Certificates

The following periods must elapse after collection before export certificates can be completed and the semen exported: -

E.C., N.Z.:	30 days
Canada:	20 days
Australia:	Nil
South Africa	Nil
U.S.A.	Nil

PLEASE TURN OVER

Please note that in most cases you require an import permit from the veterinary authorities of the country to which you are exporting the semen. It is your responsibility to obtain this.

4. Health Test Costs

There is no specific health test charge in normal circumstances for stallions whose semen is being frozen for the U.K. only. Charges for the six most frequently requested export destinations are shown below, together with some combinations. Because each importing country has different requirements, health test schedules covering a number of destinations can be complicated. In such cases, not all the semen frozen will necessarily qualify for all destinations, since countries require different periods of residence on-centre before semen collection (see section 3 above).

The costs below are a guide only and you will be billed separately by the collection centre's retained veterinary practice:
