### **BIG STAR** **2017 Frozen Semen Breeding Contract AUS**

This agreement confirms the nomination to the stallion BIG STAR (hereinafter referred to as the "Stallion") for the 2017 breeding season by the owner or lessee of the mare whose signature appears below (hereinafter referred to as the "Owner"). Owner hereby agrees to breed the mare \_\_\_\_\_ with the registration No. \_\_\_\_\_, registered in the following stud book \_\_\_\_\_, (referred to as the "Mare"). Breeding will be done by using frozen semen supplied by Stallion AI Services (hereinafter referred to as "SAIS").

SAIS advise that the optimal insemination dose for this semen consists of three straws per cycle and Deep Uterine Insemination is recommended\*\*.

#### **Terms and Conditions:**

Stud Fee: **1,550AU per straw of frozen semen**

**(up to one pregnancy only may be achieved from each single straw)**

- The stud fee does not include semen distribution costs (please contact us for further details)
- All straws purchased under this contract **must** be used on the Mare nominated above
- Straws being purchased for use in Embryo Transfer or any other advanced breeding programme are entitled to one pregnancy **only** per straw. If multiple pregnancies are achieved from the same flush or procedure, the full breeding fee of £2,700 + VAT will be charged for each additional pregnancy on confirmation of a heartbeat.  
\*\*This fee is based on the optimal insemination dose of three straws at £900 per straw
- ICSI is not permitted under the terms of this contract, but may be permitted upon request under different terms (please contact SAIS for more information)
- The Owner understands that this is a non-refundable, non-transferable stud fee and that no refund will be given under any circumstances
- The transfer or re-sale of the straws covered by this agreement is not permitted. If this is your intention, then please complete a "resale" agreement
- If the Owner wishes to sell any unused straws covered by this agreement, special permission from SAIS would be required. In that case a receipt of sale, together with a copy of a separate Breeding Contract would need completing for every mare, in order for SAIS to issue a covering certificate
